Elizabeth Elkins interview summary

The interview with Warren A. Huddleston begins with a brief discussion of his background information, including his date and place of birth and his education. From there, a discussion of some national events in the late 1920s begins. This includes Warren's and his parents' reaction to the 1929 stock market crash.

The interview continues on to the topic of the Great
Depression. Warren lived in Chicago and Pulaski, Indiana
throughout the 1930s and has many stories to tell about such
things as baseball, the movies, and Al Capone. This is interlaced
with his and his father's opinions on such world events as
Mussolini's invasion of Egypt, Hitler's rise to power, and the
kidnapping of the Lindbergh baby. Warren also discusses the
many different opinions about Franklin D. Roosevelt that he
was exposed to. This includes a lot about the WPA and CCC.

The discussion then turns to World War II. First, the events leading up to it are discussed alongside his educational predicament. General views on the bombing of Pearl Harbor are discussed. His participation in the Pacific theater is covered. His return to the United States is talked about as well as the things he did once he returned home. Throughout the aforementioned, Warren adds comments about such things as the rationing and how it affected life in rural Pulaski versus how it affected life in the big city of Chicago.

The interview concludes with a return to comparing rural Pulaski and urban Chicago during the Great Depression. Then, the atomic bombs used on Japan in 1945 and FDR's death are discussed. Warren concludes with a short discussion of how the war affected his life.
