The following are the resolutions adopted by the late democratic State Convention held at Montgomery; from which it will be seen, that the Convention as a body regret the existing State indebtedness, and desire to reduce taxation as speedily as possible; and that while it is opposed to State aid to railroads, is unwilling to regard this mere question of State policy as any test of party faith.

Resolutions of the gubernatorial Convention.
1. Resolved, That we announce as our own, the platform of principles laid down by the Democratic party at their National Convention, at Cincinnati in 1856.
2. Resolved, That as a party and as citizens we regret the existence of the present indebtedness of the State and the high rate of taxation, and earnestly desire to see the one paid and the other reduced.
3. Resolved, That we are uncompromisingly opposed to call for giving or pledging the funds, revenues or securities of the State in any shape to the advancement of works of internal improvement—That we are equally opposed to the issue of State bonds for those purposes, or the taking stock by the State in any corporation; but that regarding these questions as measures of State policy only, we decline to recognize them as a test of party faith.

The same stars which fought with the dead bodies of ancient heroes; which glared on the marble streets of imperial Rome, and on the sad eyes of Virgil, sleepless in the living glow of inspiration—the watch fires of the angels, which through centuries of devastation and change have still burned on unceasingly—speak to us as they did to Dante, and Shakespeare, and Milton, of the divine glory, the omnipotence, the beauty and love of God.

Letter from Texas.—We give today the closing member of a series of letters from Texas by Rev. N. A. Davis, which have proved so interesting to our readers for some weeks past, in consequence of the plain and familiar manner in which the most important facts regarding climate, soil, &c. are communicated.
From what we can learn there is likely to be a larger emigration to Texas from this County the ensuing Fall than any year since its settlement. In addition to others we have mentioned as having returned from Texas, we may mention also Col. J. R. Green of Alexandria, and Mr. Sydney Green, who resides seven miles north of this place; the latter of whom has purchased land in Texas with a view to removal there, and offers for sale his valuable plantation seven miles above here.
We traveled with those gentlemen on their return home on the same boat from Mobile to Selma, and received from them much interesting information.
CALIFORNIA.—We have been permitted to take the following extracts from a letter from R. K. Love, of California, to his father, John M. Love, Esq. of this County, which will doubtless be of interest to any of our readers who may contemplate emigrating to that far distant region of gold, or have friends already there. Mr. Love has been in California about seven years, and we are glad to learn has been remarkably successful in his business enterprises.
April 1st, 1857.
"I am still at the old stand, trying to furnish the miners with provisions to live on and tools to work with, and in addition I have invested some capital in mining claims and making ditches for the purpose of selling water. I have a good show in mining claims & ditches, if I could stay, but intending to close out at the first opportunity I cannot make much on the amount invested. We have a fine show for mining this season, in what is termed the dry diggings, owing to having an abundance of rain the past winter, and also many new ditches completed the present season.
