FIGHTING IN MISSISSIPPI.

MEMPHIS, Aug. 11.

Special to the Appeal from Helena Arkansas Aug. 11, 1874. At seven o'clock last night three ladies and two gentlemen arrived here from Austin in a skill and reported considerable fighting late yesterday evening. The commander of the white force was not seen, but a dismounted company of 25 men on the road to Cold Water Station on the Mississippi and Tennessee Railroad, and captured a number of negroes who were attached to two miles from town and brought them in as prisoners and dispersed them. One of them, as they were being put into the Court House yard, tried to make his escape, when he was fired upon and killed, and in the melee which ensued another negro was wounded but not fatally.

Later.—In the evening a larger body of negroes advanced from the north and attacked the town driving in the white skirmishers to the Court-house, where the main body of whites were stationed. Georgetown, in this State, is the scene of a dangerous contest between two negro factions, led by Rowley and Jones, negro members of the Legislature, each of whom seeks to control the county, in which the negroes have a huge majority. A Rowley meeting on Wednesday was broken up by the Jones faction, and one colored by-stander dangerously wounded. Runners were sent out, and armed Jones negroes rushed into the town during the night. Some of them next morning attempted to kill Rowley, and at midnight Thursday there was a heavy firing which was found to be an attack on the house of Jones who was slightly wounded. Some other slight casualties also occurred. On Friday Rowley's house was attacked, and Rowley, to save his life, surrendered to the sheriff and is now in jail. Saturday at noon the excitement was still intense and the town filled with armed negroes. None but Radicals were engaged in the riot, but the white citizens are alarmed lest some careless word or act should cause an attack upon them, which they have no means of meeting.

**THE LATE ELECTIONS.**  
BRILLIANT CONSERVATIVE  
VICTORIES:

At the election for reporter of the court of appeals, Aug. 3, Kentucky gave a Conservative majority of about 50,000.  
We have also recorded the glorious victory won, Aug. 3, by the Conservatives of Vicksburg.  
An election for county officers in Tennessee, Aug. 6, shows immense Conservative gains. Memphis gave a Conservative majority of 5,000, and Shelby county (in which Memphis stands) gave over 4,000 majority; and this against 2245 majority for GRANT in 1858. Knox county gave about 600 Conservative majority, against 2461 for GRANT in '68. Nashville gave 2500 Conservative majority to the Radicals have often carried it by large majorities. One telegram says every county in Tennessee went for the Conservatives, but that is hardly true.  
But the election in North Carolina is a most happy and memorable event. It occurred Aug. 6, and was for members of congress, superintendent of education, judges, the legislature, and county officers. The vote for governor in Aug. 1872 was 98,000 Radical to 96,731 Conservative, yet the Conservatives carried 5 of the 8 districts; but GRANT beat GARRETT the following November 24,830 votes. Now the Conservatives carry the state by about 12,000 majority, elect 7 of the 8 congressmen, increase their majority in the legislature, and sweep every judicial district! Wake county (Raleigh) went Conservative the first time since the war. It may well be said that if the Conservatives are prudent the reign of Radicalism in North Carolina has ceased forever.  
These elections show clearly that the people are rising up against the dose of social degradation the Radicals have mixed for them, and labelled the Civil Rights Bill. The fact that this country will have no prosperity till Radicalism is overthrown is beginning to take hold of the minds of all intelligent men, who see that prompt action must be taken to crush out the fearful scourge.

**The White Man's Party.**  
The result of the Tennessee, Kentucky, and North Carolina elections is a splendid vindication of the policy of the Democratic and Conservative party. Men have been compelled to look grave questions in the face, and say, unequivocally, whether they were for or against their own race. The result has been that the lovers of their race, the lovers of their land, and the lovers of our institutions, of economy, and of honesty in public affairs, have all united their strength, and administered to radical supremacy a blow the like of which has never felt before, and from which it will never recover.  
From these victories, all of them in former strongholds of the radical party, that party may read its doom before the people. The whole country, South, East, and West, has watched with breathless interest the contest in these States, and on account of the new and startling test of political brotherhood which it has established, the negroes and negro-ploists of the South have watched its results with intense anxiety. Had the white men failed to rally on this issue they would know that their failure would be the toxin of unlimited license to the negroes of the South in their insane demands for social supremacy.  
But the triumphant success of the white man's party at Memphis, Nashville, Vicksburg, in Kentucky and North Carolina, has been the handwriting on the wall which has caused the knaves of the political Beshazzar to smite together, and has struck terror to the heart of the radical party. On the other hand these victories are guardians of future and grander successes to the Democratic and Conservative party in its glorious crusade for the liberation of the land from radical corruption and negro misrule.  
Carter County is very much excited over the election. Republican Sheriff elected by only one vote. The report is very current in Elizabethton, that a certain well known gentleman, who was a judge, at dinner took up the ballot box and carried it three quarters of a mile alone, from the voting ground, which was on Stony Creek. Twenty-seven ballots only were in the box for the Democrats. 54 men of said precinct say they voted for the Democrats. Something wrong, straighten it; out gentlemen.
