The Missouri State Alliance defeated U. S. Hall for re-election as president; but the same body refused to endorse the land loan and sub-treasury scheme, and remitted the subject to the sub-alliances.

The Georgia legislature failed to relegate the old war horse Gordon to the rear, but it got in its work on the old Confederate privates in a way to gladden the hearts of the loyal Republicans of South-hating Kansas.

The third party people are spreading their net for the Democratic Alliance of Alabama, but they will not catch them. Here and there a foolish young bird will go into it; but the wary old birds of our party will walk round it.

The cotton outlook all over the South is rather gloomy, and the price is going up. Cotton is being freely marketed in Montgomery and other Southern towns. The present price is nearly eight cents. New York cotton market shows a gradual advance.

Candidates for county offices have begun to announce in some of the counties of the State. In Calhoun up to date there has been no public announcement of candidacy but reports say the woods are full of them. There is evidently a lively time ahead in politics.

The Mississippi State Alliance expelled W. S. McAllister, the anti-sub-treasury State Lecturer. McAllister charged this to Dr. C. W. Macune, and the two men meeting next day a fight ensued. McAllister got the better of fight, but Macune got the better of him in the State convention.

Gold is flowing into this country in a great stream to buy the wheat that Europe needs and the stringency in money is gradually giving way. Fully five hundred million of dollars will be added to the currency of this country next year by the sale of our surplus products over that of any other year. There is good times ahead.

The Governor has appointed Hon. Hector D. Lane, of Limestone county, to succeed Hon. R. F. Kolb as Commissioner of Agriculture. Mr. Lane is one of the most prominent Alliances of the State and was a member of the last House of Representatives. Mr. Kolb's term of office expired by limitation the 1st of September.

Senator Peffer's paper says that if the Alliance accomplishes nothing more it will do enough if it succeeds in breaking up the Solid South. That such is the design of these Kansas Radicals who have been speaking throughout the South is too apparent to doubt; but they will not succeed if Southern Alliances are true to their section. We think they will be.

The Atlanta Journal has an appropriate cartoon representing the action of the Georgia Legislature in refusing to accept and support the Confederate veteran's home. It is a picture representing a young Confederate soldier going through the manual of arms with the inscription beneath, "support arms." Beside this picture is another representing an old one-legged Confederate soldier with a crutch and underneath this is the inscription, "support yourself."

The Georgia State Alliance passed a resolution paying the expenses of Jerry Simpson, Mrs. Lease and the other third party evangelists from Kansas and then very appropriately passed a resolution "demanding" that the legislature refuse to accept and support the Confederate veterans home, built by the people of Georgia at an expense of fifty thousand dollars, and offered to the State as a free gift.

After the defeat of the bill to accept the Confederate soldiers home, built by the loving tribute of those noble Georgians who yet revere the Confederate soldier, a great indignation meeting of ten thousand people was held in Atlanta and the Legislature was denounced in the roughest terms by men of all classes, including eminent ministers of the gospel. The feeling spread throughout Georgia, and there is profound disgust throughout the State at the action of the 91 members of the legislature whose vote defeated the bill.

The grain crop of the West has been immense. The Kansas farmers will make one hundred million dollars clear this year, and it is said they are paying up their interest and calling in their mortgages where they had about despaired of being able to save their lands. Crop failure in Europe has advanced the price of their immense crops.

The grain crop of the South is also large, and this will be of immense benefit to Southern farmers. If they had been compelled to buy next year's supplies at the high prices which will rule they would be greatly damaged. But they have made almost enough to do them, and when cotton is opening up at a much better price than was expected, and things look bright all around.

The Alliancemen of Piedmont beat had a joint discussion Thursday. President Adams and Mr. Longshore and Mr. L. V. Grant were invited to speak. Mr. Adams was not present. Mr. Longshore spoke at length and defended the Ocala demands in full, particularly the sub-treasury bill. Mr. Grant replied. He disclaimed any hostility to the Alliance, and declared himself entirely friendly to the interests of the farmers, but he took square ground in opposition to the sub-treasury, land loan and government ownership of railroads as tending to centralization, as corrupting in tendency, as leading to third party action and as destructive not only of the interests of the government, but of the Southern farmers as well. The audience was composed almost wholly of farmers and those present from the outside say that three-fourths of them were against the three planks of the platform mentioned above.

The State Alliance organ and writers in the same, and stump-speakers for the sub-treasury bill are all attacking Senator Morgan. One writer in the Herald goes so far as to attack his moral character. Now what is all this for? President Adams first attacked Senator Morgan in a bitter way, and when he replied in terms of biting sarcasm, it served to set all the gang of writers and speakers at his heels. It appears as if Mr. Adams and his adherents claim the special privilege of doing all the attacking. If one of the victims of their spleen replies, it is forsooth, "undignified, unbecoming," etc., etc. War is being raised on all the old and trusted leaders of the Democratic party, and we cannot understand why they may not be permitted to defend themselves.

If any one doubts that the sub-treasury bill is to be made the basis of third party action next spring and the means by which the attempt will be made to take Alliancemen outside the Democratic party, let him read the remarks of Senator Peffer, reported in a dispatch from Topeka, Kansas, relative to the failure of the Missouri State Alliance to swallow the sub-treasury. He says this action will cause some delay, but the Alliancemen will all have acted on the sub-treasury plan in time for the campaign of 1892, and he adds: "I think the Cincinnati (third party) platform will be practically the one on which the campaign will be fought by the people's party." It is time Democratic Alliancemen were getting their eyes open.

The Fourth District Alliance, at its recent meeting, sent greeting to the Western farmers and encouraged them to hold to their corner on wheat, even if we (the Southern people) had to pay one dollar a barrel more for flour. Seeing that the Southern farmers raise only about three hundred million dollars worth of stuff to sell while those fellows raise over one thousand million, this action of our people is generous, to say the least of it.

Mr. Kolb will contest Hon. Hector Lane's right to enter upon the duties of the office of Commissioner of Agriculture. Mr. Lane will take steps at once to assert his right to the office through the courts. The matter will probably go before the supreme court before it is done with.

It does not require any remarkable degree of political sagacity to see that the issue for the Democracy to win on next year is the tariff. On that question the party has been fighting for a number of years, are solidly united and have just come to fully understand it. Appreciating all this, the Republicans have already shown a determination to divide the issue, and although Mr. McKinley, the author of the present tariff law is the representative of that issue, in Ohio they have pushed the siver question to the front and are striving to make that the head and front of the canvass. The Democrats are standing by the tariff resolutely and will elect Gov. Campbell this year and a Democratic President next year.—Montgomery Advertiser.

A country judge in Hungary gave a decision a few days ago of which Solomon himself might be proud. Members of the Nazarene sect in the town of Gyoma requested His Honor to be allowed to crucify one of their number "who was a Messiah, and had been called by heaven to save men." The judge for a moment was dumfounded. "Friends," he replied, after recovering his senses, "I do not wish to interfere with your religious practices. If your Messiah wishes to be crucified let him prepare himself for death. Remember, however, that if he does not rise again in three days, I shall cause every one of you to be hanged." NO DOUBT OF KOLB'S CONTESTING.

His Attorneys Give Formal Notice of His Decision.

The contest over the office of Commissioner of Agriculture is now a certainty. Capt. Kolb's attorneys—Messrs. Brickell & Gunter, yesterday notified Messrs. Watts & Son, Commissioner Lane's attorneys, that Capt. Kolb would not surrender the office. It had been agreed between the attorneys that the formal demand by Commissioner Lane shall be considered made and refused by Capt. Kolb, and that then Messrs. Watts & Son, representing Commissioner Lane, shall institute proceeding before Judge F. C. Randolph, of the Montgomery County Probate Court under Section 302 of the Code, which The Advertiser printed yesterday. Commissioner Lane through his attorneys, will waive complaint that the books, papers, property and money, of the office of Commissioner of Agriculture and in the possession of Capt. Kolb, who refuses to vacate the office and will pray the Probate Judge to grant in order requiring Capt. Kolb to show cause why he should not be compelled to turn them over to his successor.

The case is likely to be brought before the Probate Judge immediately and an early day will probably be set for the hearing. If Judge Randolph should decide that Capt. Kolb must deliver the property to Commissioner Lane, and this order should not be obeyed, the Judge, under Section 304 of the Code, could commit Capt. Kolb to jail until he changed his mind. Whether this result will follow is, of course, mere speculation. On the other hand, it may be possible for him to give a supercedens bond from the court's judgment, if it should be such, and appeal. Whatever may be the outcome of the trial before the Probate Judge, the losing side will, of course, take an appeal to the Supreme Court, which will finally determine the matter. It is probable that the proceedings in the Probate Court will mainly be a formal preliminary to reaching the court of last resort.

The Supreme Court does not convene until early in November, so that the contest will not be really settled until after that time. In the meanwhile it may be possible that there will be two offices of the Agricultural Department. When Commissioner Lane qualifies, he can open an office and go ahead discharging his duties regardless of Captain Kolb as a usurping Commissioner elsewhere in the Capitol. Commissioner Lane would, of course, be recognized by the Governor, and under the Attorney-General's opinion, by the Auditor and Treasurer. The latter officers would pay the Commissioner's salary to Mr. Lane, and would recognize his warrants on the funds of the Department.

The result would be that Captain Kolb's office would run without funds, at least until the Supreme Court's decision.

Commissioner Lane is expected back today, when he will probably qualify and receive his commission. It may be possible that the first step in the contest will begin today.

This is the first instance of a contest over a State office since 1890, when ex-Governor Smith and ex-Treasurer Bingham, of the Republican regime, refused to give up their offices to Governor Lindsay and Treasurer Grant. Those usurpers held out only a few days.

In connection with the Commission's report, it is interesting to note that Capt. J. C. Cheeney, ex-Commissioner Kolb's former chief clerk, has announced himself a candidate for Commissioner before the next State convention, inasmuch as the office becomes elective next year.—Montgomery Advertiser.

SENATOR PEFFER.

Says the Sub-Treasury Scheme was not Defeated by the Missouri Alliance.

TOPEKA, Kas., Sept. 1.—Senator Peffer, who returned from Iowa yesterday, denies that the sub-treasury scheme was defeated by the Missouri Alliance. The "Missouri Alliance" said Senator Peffer, to-day, "has done the correct thing. The sub-treasury scheme is a proposition for the people to decide and they will be right. Sub-treasury advocates had enough votes in the convention to have carried the plan, but they disappointed politicians by allowing sub-alliances to settle the question.

The sub-treasury scheme was not defeated it was simply referred to the sub-alliances. Had it been a convention of Democrats or Republicans with a majority they would have fastened their ideas on the people, who would have been compelled to submit. The action of the Missouri convention will result in delay, but the Alliancemen will all have acted on the sub-treasury plan in time for the campaign of 1892, and I think the Cincinnati platform will be practically the one on which the campaign will be fought by the Peoples Party."

PRIVATE BRAGG.

He was not an Officer But a Brave and Honored Soldier.

The following concerning the late Capt. Bragg is from the "Murmers of the World" in Sunday's Age-Herald: The late Walter L. Bragg was really never an officer in the Confederate service, and the truth about the matter is greatly to Mr. Bragg's credit. He enlisted as a private in an Arkansas company and at once became the most important individual in the regiment to which he was attached. He was not only a man of strong intellect, but he was one of those men, seldom found in real life, who have no sense of fear. His physical courage was absolute. Thousands of men in Johnston's army knew Private Bragg. His influence was greater than that of the Colonels. He resolutely declined to accept promotion, saying always that he preferred to remain a private. Private Bragg became noted as a sharpshooter and the Confederate Government receiving a consignment of twenty-five improved rifles—Martini Rifles, it is believed—were divided between Johnston's and Lee's armies, ten of the guns going to the "Army of the West." Ten picked men were selected, amongst them being Mr. Bragg, and the guns were placed in their hands. The other nine soldiers were put under the immediate command of Mr. Bragg, and they were sent out to shift for themselves, so to speak. Those improved guns were capable of killing men at a distance of one thousand yards, and many a federal officer was brought down by the famous "sharpshooters," under the command of Private Walter L. Bragg. The newspapers called him "General," Bragg the other day. Here in Alabama, he has been always known as "Captain." But he never bore either title in active service. He was plain Private Bragg, but a braver man never wore the epaulettes or stars of an officer. He refused official distinction, but he won real fame in the cause which he espoused. Walter L. Bragg was as modest as he was brave.

It is adding another honor to the memory of Mr. Bragg to set him down as a private. In these days of the absurd abuse of titles, "mister" is no mean distinction. No other people under the heavens run after titles to the extent that we Americans do. Yet cheap newspaper writers talk of plain Alfred Tennyson; and great journals persisted in calling Sackville West "Mister" long after he was a peer of Great Britain, and at the time filling their columns with the doings of "generals" and "colonels," who would't be able to tell a sword from a bayonet. Let us be consistent in our title-worship.

A NOBLE FAILURE.

In these times of loose notions of personal honor and commercial integrity it is pleasant to read of the conduct of the Moses family, of Montgomery, Ala., in connection with the recent failure of Moses Bros., one of the largest banking houses of that city, in a speech at the meeting of the creditors Alfred H. Moses, of Sheffield, avowed his partnership with his brothers in the broken firm. He added: "I assert most positively, that if our assets fail to pay our indebtedness, dollar for dollar, we would never feel absolved from an obligation to pay the difference, if ever in our power. Notwithstanding this, when we concluded to make an assignment I suggested that we should keep out of our homes, as the remainder of our property was much more than enough to pay our liabilities, and as we could afterwards, if necessary, convey our homes to the trustees. My brothers insisted that they would include their homes in the assignment, but that as I was an invalid, it did not follow that I ought to do so. Finding them determined, I said I would include my home too. And we all did it. Our wives volunteered to relinquish their rights of dower, which, in such an immense amount of real estate were worth a fortune, and which they were not under any legal or moral obligation to relinquish. They knew and appreciated our earnest desire that our creditors should be paid in full, without reference to whether we would have much or little left. They do not own one foot of ground. Our sisters, actuated by like motives, conveyed to our assignees, for the benefit of our creditors, all of their real estate, with the exception of an heirloom in the city of Charleston, which has been in the family for more than 100 years, and which we were unwilling for them to convey. Our wives and sisters preferred the protection of our creditors and our commercial honor, to their own comfort."

The chances all are that with their credit and the ability which built their former fortunes the Moses brothers will, before many years again enjoy prosperity. Honor tells in commerce; with shrewd business men character very often counts more than assets, and a clear reputation is good capital. Whether these men die rich or poor, however, is a matter of comparatively little importance. They have made a name which no dollars could have bought for them and which they could not afford to sell for the combined wealth of all the Vanderbilts, Astors and Goulds. They have established an inheritance for their children richer and higher than any accumulation of money that could be piled up.

Money is a good thing to have. It can buy luxury and power and outward evidences of respect from the servile. It cannot, however, buy good opinion or real regard or the countenance of honest and independent men. Nor can it give a man a clear conscience, self respect or the consolation that the knowledge of a life unstained brings at the hour of death.

A man's character is the one real thing in life—the one thing subject to no chances of fortune or changes of time, which no power can take from him or deprive his children of. It is well worth enduring poverty or sorrow for, well worth dying for.

These Moses brothers are Hebrews. They are an honor to their race and to the commerce of the country. They have achieved a splendid triumph in their time of disaster and are far more to be envied than any of the rich and so-called successful men who have piled up dollars and secured power by swindling, deceit, sharp practice and use of the technicalities with which the law makes fraud easy and respectable.—Aniston Hot Blast.

Democracy and The Alliance.

Some of the democratic papers of the South are advocating the idea of severance between the Democratic party and the Alliance. A certain Nashville paper says: "The latter (the Alliance) has become so thoroughly a distinct and hostile political party that no member of it should be allowed to vote in Democratic primaries or to participate in democratic conventions." On the other hand some of the county Alliances are pledging themselves to vote for no man for office who does not endorse the demands of the Ocala platform; and at the recent meeting of Alabama State Alliance at Brundidge in this state President Adams stated that he would suffer his right arm burned off before he would vote for Gen. John T. Morgan, or for any man who would vote for him; a statement, by the way which no one believes.

Now, there is intemperance and possibly danger in those rankings. They do no good, certainly. There is neither argument nor reason in them. They convince no one and are calculated to bring about an estrangement that we cannot afford. The Alliance is a strong organization, but it is not strong enough to stand by itself. The Democratic party is a much stronger organization but not strong enough in the south to cut loose from the Alliance. Neither is such a course at all necessary. The farmers of the country, the agricultural class, think and with reason too, that the drift of public legislation for the past twenty to thirty years has been detrimental to their interests. But who is to blame for this state of affairs, if such a state exists? Certainly not the democratic party for it has never, within

that time, had full control of all branches of the Government. The Republican party is responsible for the national legislation of the past thirty years, and boasts of the fact. Yet the separation of the Alliance from the Democratic party in the southern states could only result in the reinstatement of the Republican party in power in that section, and the perpetuation of that power in national affairs. Some of the demands of the Alliance are old-timed, true Democratic doctrine. Some of them, no party can advocate and live. The Democratic party has always been the friend of the laboring man and the poor man. During its long period of existence it has never advocated a government of the people by the people and for the people; local self government has been one of its corner stones; opposition to class legislation, another; while its keystone has been "taxation sufficient only to meet the absolute necessities of an economical government." The sub-treasury and land loan schemes of the Alliance are a delusion and a snare. We need have no fears that they will ever be enacted into laws in this country. They are contrary to the theory of our government and will go the way of the Greenback craze of a few years ago. We deprecate harsh and intemperate language on the part of Democrats and Alliancemen alike. The great white race of the South must stand together so long as we are menaced with negro domination. Self preservation demands this, and any thing else would be suicide.—Fort Payne Journal.



THE ALLIANCE IN KANSAS.

The Following Dispatch Alleges That It Is Going to Pieces.

TOPPEKA, Sept. 8.—Every indication points to the fact that the Farmers' Alliance in Kansas is gradually going to pieces, and with it a significant decrease in the ranks of the People's party. While the leaders of the movement maintain that they are retaining their strength, information from reliable Republicans and Democrats from all sections of the state is to the contrary notwithstanding.

Last year the Democrats of Kansas hailed the Alliance movement as a co-worker to destroy their ancient enemy, the Republican party. They did not nominate county tickets in over a half dozen counties in the state, but threw their votes to the new People's party. Now it is exactly the reverse and the Democrats have tickets in nearly every county, and are fighting with the Republicans in fighting the People's party and the Alliance as a common enemy.

In eight out of nine judicial districts the Republicans and Democrats have combined to elect the Democratic candidate nominated by the People's party. They claim that the good name and credit of the state are too dear to them to allow an election to the bench which would overturn the present condition of things.

Last year 50,000 Democrats left their party and voted with the Alliance, or People's ticket. They did it because they were disgusted with the Republicans. They made it possible for the Alliance to corral a United States senator and five members of congress. As soon as the Alliance party accomplished this feat, they commenced abusing both old parties, and declared that they wanted nothing to do with them.

Recently there has been a marshaling of forces all along the line in Kansas, and thousands of Republicans and Democrats have withdrawn from the order and from the People's party, and declared their intention to hereafter affiliate with their old parties. It comes from all parts of the state. Republicans predominate in this exodus, but thousands of Democrats also declare no further allegiance to the Alliance party. Democrats and Republicans see there is no break in the solid Democratic front, and they will not forsake their respective parties here in Kansas and become chestnut pullers for Polk, Livingston, Macans, McDowell and others.

THE CONVICT QUESTION.

A New Idea Suggested That May Be Put into Execution.

NASHVILLE, Sept. 8.—The chairman of the penitentiary committee of the Tennessee legislature has received a proposition from the Tennessee Coal, Iron and Railroad company, and it will probably be submitted when the two houses meet. As far as can be learned, the proposition is about as follows: The contract providing for the payment by lessees of \$100,000 a year to the state is to be canceled. The lessees are to build a new prison at the head of Sequatchie valley, to cost several hundred thousand dollars, under direction of an architect to be appointed by the state. In this building are to be kept prisoners not able to work in the mines.

A stockade shall be built for convicts in Marion, Pleasos and Sequatchie counties, and able-bodied convicts are to be placed in the Tennessee Coal, Iron and Railroad company mines in these counties, but no where else. The lessees are to pay the state \$250,000 for the labor of convicts during lease, running from twenty-five to thirty years. The state is to pay for clothing, feeding, transporting and guarding convicts. The lessees are to be given the site on which the present main city stands in this county. They will give 500 acres of land where a new prison is to be built, on which partially disabled convicts can raise products for their own consumption. The building of the new prison is to begin without much delay, and the new convicts are to be placed in it as soon as the legislature will pass the general assembly with some modifications.

ITALIAN ITCH.

A Contagious Skin Disease Brought to America by Italian Immigrants.

MORRISTOWN, Penn., Sept. 8.—People here are alarmed at the rapid spread of a contagious skin disease, called the "Italian itch," or scabies, occasioned by the presence of a minute parasite, transmissible from one person to another. The disorder here is affecting all classes alike, and the best families and most refined people are among the sufferers. It is traced to the imported Italian laborers who have recently been employed in this neighborhood, and has spread both up and down the line of the Philadelphia and Reading railroad and along the line of the New Trenton cut-off from Morristown to Glenloch. Wherever these Italians have been, they have left this trail of annoyance and suffering.

Notes and coin are said to be the most frequent medium for its transmission, first from the Italians to the shopkeepers and then to the people generally. The soft parts of the skin between the fingers and about the wrists and elbows are most frequently affected. The acarus usually attacks both sides of the body simultaneously, and in adults it is never found on the face or scalp, but any other portion of the body may be affected.

SHORT ITEMS.

Important General News Dispatches in Condensed Form.

The cotton crop has been greatly damaged by the recent rains.

October 10 is the day set for unveiling the Grady monument in Atlanta.

The story about the collapse of the oil boom in Moulton Valley, Ala., is denied.

Captain James Franklin, Sumter county, in the owner of several famous horses, has died.

The president has appointed John S. Omahum, of Kentucky, a colored man, minister to Haiti.

The lady managers of the World's Fair are opposed to having the exhibition open on Sunday.

The Central American states are now making active preparations for representation at the World's Fair.

Frank Danforth, the negro who murdered his wife a few months since, was hanged in the jail yard at Augusta, Ga.

The bandits who robbed the Southern Pacific express at Savannah, Tex., secured \$15,000, instead of \$2,000 as first reported.

A Rome dispatch states that the Vatican has for the third time refused to accept Russia's nominee for the vacant bishopric in Russia.

The Egyptian cotton crop amounts to 3,700,000 hundred weight, the largest crop on record for the season promises an equally large yield.

Dr. Lorimer, a Baptist minister, in a sermon at Chicago, Ill., said that Sunday was not a sacred day, but it should be a day of rest and amusement.

The Kennedy family of Dubuque, Ia., have received word that by the death of an uncle of the same name in Newark, N. J., they are left heirs to an estate valued at over \$1,000,000.

An Edinburgh news dispatch says that the recent storm which swept over the British isles have half ruined the crops throughout Scotland, and the harvest is at a complete standstill.

Zach Truesdell, a highly respected and prominent farmer of Westshaw county, S. C., committed suicide by shooting himself in the head with a shotgun. Mental aberration is the cause alleged.

Assistant Secretary Nettleton has instructed the collector of customs at Nogales, Ariz., to prevent the smuggling into the United States of that port of Mexican lottery tickets.

The loss by fire at Attalla, Ala., aggregated \$70,000; insurance \$30,000. It is supposed to have originated in Dan's store, from an exploded lamp. The burnt district will be immediately rebuilt with finer buildings.

The forty-five detained Russian immigrants, who arrived at Baltimore in the steamer Scandia have been released. The steamship Karlsruhe, from Bremen, has 737 passengers in the steerage, 200 of whom are Russian refugees.

R. G. Dun & Co.'s weekly review of trade says that business is growing everywhere and that prospects are good for a fine fall and winter trade, and that the advance in cotton is having a stimulating effect in the south.

Official statistics show that 6,200,000 of rice were exported from Russia to Prussia between Aug. 9 and 27. Pennsylvania near Vint has murdered the wife and family of a Jew who bought up several million roubles' worth of rice.

The body of Mr. Alfred Kennedy of Tazant county, Ga., was found in Bull creek shot in the shoulder and side and badly lacerated. The above named man was one of the best citizens of that county and the murderer is a mystery.

M. T. Able has assigned at Harrodsburg, Ky., assets amounting to \$200,000, of which he is interested in Birmingham and Florence, Ala., and Wichita, Kan., and is supposed to have property to meet all his debts, but was forced to the wall by his creditors demanding immediate payment.

At Louisville, Ky., the directors of the Falls City bank, a meeting decided not to prosecute Major William Tillman, the cashier who fled to Canada. This was done on recommendation of the counsel, who advised that Tillman's offense was only a breach of trust and that there was no hope of a conviction.

Miss Ethel Tansel, a lovely young girl, daughter of George F. Tansel of Merrellville, Ind., chased a chicken into a stall occupied by the family horse, and although the animal was a pet it turned upon the girl, knocked her down and trampled upon her until the flesh of her body was beaten to a pulp, one arm was broken and her skull fractured.

In a communication just made public, Mr. Gladstone writes in favor of increased representation of labor in parliament, but depreciates the formation of a labor party. His objection to such a party in his own words, is on the ground that "if every class of the community exercised the right to form a party we should have a queer parliament."

The State bank of Sloan, Ia., was robbed and \$4,000 in cash was secured. The vaults were prized open and the safe inside blown open. No trace of the robbery was found until this morning. The robbers stole a team at Sloan, and drove to Correctionville thirty miles northeast, and robbed the post office there of \$50 in cash and \$150 in stamps. The team was turned loose and found, but the robbers have not been found.

The little town of Farley, Ia., is torn up over a sensational affair which took place on the north side of the village. Dr. Lambert a prominent physician, was attacked and severely horsewhipped by Mrs. Tucker, with whom he had quarreled. The doctor took the whip to the woman and scolded her in the gutter, when the husband appeared and gave the doctor a terrible beating. Mr. Tucker was arrested and fined \$50.

The most novel of all sports was inaugurated at Houston, Tex., a goat race, gotten up by the sporting editor of the Houston post in a spirit of levity. It proved more than a joke, however, and 5,000 people turned out to see it. There were sixty entries and the turfmen made books on the result and hundreds of dollars in pools were sold. Never was there such a sight before. The mayor and other city and county officials acted as starters and judges. Some of the goats made the 300 yards in 32 seconds in harness.

GREAT STRIKE IMMINENT.

The Colored Alliance Refuses to Pick Cotton at Low Prices.

HOUSTON, Sept. 7.—The biggest agricultural strike in the history of the world is imminent. If it takes place the matured cotton will rot in the fields. This is brought about by the colored Farmers' Alliance of the United States. And the order goes into effect on Saturday next.

This organization has been perfected through colored Alliances, and numbers more than half a million with thousands being added every day throughout the southern states. Colonel R. M. Humphrey, general superintendent of the Colored Alliance, admitted the existence of this organization, saying it had been induced by the organization some time ago of planters and merchants in certain sections, notably Memphis and Charleston, to reduce the price for picking to a very low standard, and that the cotton pickers had combined to protect themselves from this dictation, and he thought they would be able to do so.

It is learned that a secret circular has been mailed at Houston to every sub-Alliance throughout the cotton belt, fixing the date when the strike of cotton pickers will be simultaneously inaugurated, and that they shall be conducted. The headquarters of the Colored National Alliance of the United States is in this city. Colonel R. M. Humphrey, general superintendent of the Colored Alliance, is having actively at work in organizing the colored men for a general strike all over the south. A copy of a secret circular has been obtained, which Humphrey is having distributed by thousands all through the cotton states.

The following is the main feature of the strike:

Whereas, The planters and speculators above mentioned are firm in their demand that you pick at starvation wages, as offered by them, and leave your families to suffer fearful consequences, paying to your account the present low prices of their cotton; and Whereas, Above 600,000 pickers already have bound themselves together in sacred covenant to pick no cotton for anyone, except their own, before about 1st of October, at not less than 12¢ per 100 pounds, with board; and Whereas, Your success depends upon your united action.

Now, therefore, I, R. H. Humphrey, by virtue of the authority in me vested, do issue this, my solemn proclamation, fixing Sept. 12, 1891, it being Saturday, as the day upon which all our people shall cease from, and absolutely stop picking cotton, except their own, and shall pick no more before about Nov. 1, unless their just demand for wages shall be sooner acceded to by the planters and others interested.

GROWTH OF THE SOUTH.

The Industrial Development in the Week Ending Sept. 5.

CHATTANOOGA, Sept. 7.—The Tradesman in his weekly review for the week ending Sept. 7, reports 43 new industries, 4 new buildings and 6 new railroads, including one electric line. The most important new industries established, as reported to the Tradesman are the following:

Brick and terra cotta works at Grayson, Ky., car wheel works at Louisville, Ky., coal mining companies at Coal Valley and Prince, Va., a cotton gin plant at Harmony and Cool Springs, N. C., and Eighty Eight, Ky., a hay press factory will be established at Dalton, Ga., and a foundry at Covington, Ky. Foundries and machine shops are reported at Gainesville, Fla., Suedon and Buchanan, Va., the latter with \$500,000 capital, and one at Louisville, Ky., capitalized at \$200,000, and a machine shop at Stanley Creek, N. C. An electric power and lighting company, with \$100,000 capital, has been organized at Charleston, S. C., a railway supply company at Alexandria, Va., an ore working plant with \$100,000 capital, at Enterprise, Miss., a rolling mill plant at Alton, and a \$200,000 shoe company at Richmond, Va. Cotton mills are to be built at Camden, Ark., Elmwood, N. C., LaFayette, Ga., and Enterprise, Miss., and water-works at Gainesville, Fla. A furniture factory has been established at Marshall, Tex., lumber companies at Parkersburg, W. Va., Suffolk, Va., and Wrightsville, Ark., the last with \$250,000 capital, and a saw mill at Camden, Ark. and Farmington, Tenn., a single mill at Freeport, Dyerburg, Tenn., and near Fulton, N. C., variety works at Stanley Creek, N. C., and a furniture factory at Meridian, Miss., and Tenaha, Tex.

New railroads are reported at Atlanta, Ga., Knoxville, Tenn., Rock Springs, Fla., and Charleston, S. C., and an electric line at Knoxville, Tenn.

A business block to cost \$100,000 is reported at Ocala, Fla., a city hospital costing \$60,000 at Louisville, Ky., a jail at Shepherdsville, Ky., and school houses to cost \$15,000 at Sparta, Ga.

LABOR DAY.

Workmen Have a Great Time Throughout the Country.

ATLANTA, Sept. 7.—Labor day was observed generally throughout the country, especially in the larger cities, by a festive page, and thousands of the American workmen gathered together while the bands were playing and flags were flying and formed lines of marches, that contained in each hundreds of men who gain their daily sustenance by the sweat of the brow.

The greatest parades were had in Chicago, New York and Baltimore, but there in other cities were none the less grand in considering the relative sizes.

Killed While Plowing.

ANTIGO, Wis., Sept. 7.—A farmer named Westland residing on a farm near the railroad track, was killed while plowing. His team became frightened and the engine and he were thrown to the ground, the plow cutting his body in two.

THE NOTORIOUS COLORED OUTLAW.

Harmon Murray, Is Killed by a Negro Land of 17.

JACKSONVILLE, Fla., Sept. 5.—Harmon Murray, the notorious colored outlaw, who has defied the authorities for nearly a year and terrorized a wide section of the country, was killed by Harry Early, a colored lad of 17. The killing occurred in a swamp near Archer. Murray called on Early about 4 o'clock a. m., and ordered him to go with him to Archer, where, he said, he was going to "kill some crackers" and then leave Alachua county. Early did not want to go, and said he had no gun, but Murray took Early to the latter's brother's house and made him produce a double-barreled shotgun. Both barrels were loaded with buckshot, and Early put fifteen more in each barrel. The two then started toward Archer, having to pass through a swamp on the way. When they got into the swamp Early produced the gun and told Murray to lead, and immediately Early poured the contents of both barrels into the back of Murray's head, killing him instantly.

Early then notified the police at Archer, and a crowd went to the spot, brought the corpse to town and afterward sent it to Gainesville. The excitement there was intense, as several Lynchings of Murray's confederates have occurred in that vicinity. Early was the hero of the hour, and was mounted on a box, from which he made a speech describing the affair. He will get \$1,500 in reward. Murray had killed seven men within the past few months, and was as fearless as he was bloodthirsty.

AFFAIRS IN CHILI.

The Country Has About Settled Down to Ante-Bellum Quiet.

NEW YORK, Sept. 5.—A cablegram from the Herald from Santiago says affairs in Chili have almost settled down to ante-bellum quiet and order. Nothing is decided yet regarding the elections, and the establishment of a constitutional government. It will take several weeks at least, before the necessary arrangements for the election can be completed and in the meantime Junta will administer the affairs of the country.

The governments of Brazil and Peru have officially congratulated them on the victory of the Congressional party and the restoration of peace.

A decree has been issued by Junta announcing that notes issued during the revolution by Balmaecia be recognized as legal by the government. The investigation of banks shows many of Balmaecia's officials have taken care to feather their nests.

The balances, ranging from \$20,000 to \$1,000,000, carried by the banks are known to be poor, but the child in the trouble. Such balances will be confiscated.

A SHOCKING AFFAIR.

An Infant Attacked with Fits Is Boiled Alive.

PETERBORO, Ont., Sept. 5.—A shocking affair has just come to light here. About two weeks ago a 2-year-old child was attacked with fits. While in a fit the old-fashioned remedy of putting the child into a pan of warm water was tried. The water was not sufficiently hot, and the child was removed from the pan and the pan with the child in it was placed on the opening for the purpose of heating the water. The child writhed in agony, but the women in attendance, deeming it the result of the fit, paid no attention. Finally the child was removed, and when the child was taken out of it the skin and flesh peeled off its body in large pieces. The child died soon after. The authorities are investigating the case.

A REMARKABLE DISCOVERY.

Dr. Sletch of Berlin, Finds Water to Be a Pain Killer.

BERLIN, Sept. 5.—A rather remarkable discovery has just been made by Dr. W. L. Sletch of this city. He was conducting experiments with a view to determining how best a solution of cocaine would prove efficacious as a local anesthetic, in minor surgical operations, when he stumbled upon the fact that simple water injected under the skin with a syringe renders the flesh at that point insensible to pain. The effect of the water is to create a slight swelling resembling that caused by the sting of a gnat. The space marked by the swelling remains insensible to pain for some minutes, so that incisions can be made without causing the slightest pain.

A CITY WITH BUT ONE HOUSE.

MASCOUTAH, Ill., Sept. 5.—There is a modest club house on the high banks of the Kaskaskia river, five miles southeast of here. It is the only building in the platted city of Highlandville. The city is named by Captain Lawrence, an aboriginal Frenchman, thirty-five years ago, and a great many lots were sold in New York and the east at fancy prices, and they have no doubt been waiting all these years expecting to find themselves the possessors of valuable property in a thriving western city. The lots were sold for taxes long ago, and a backwoods farmer now raises fine corn, cabbage and potatoes upon them.

Indictments Against Saloon Keepers.

MEADSBURY, Sept. 5.—The grand jury of this county found 511 indictments for retailing liquor without state and county licenses. There are 743 persons and firms engaged in the traffic who pay the intricate revenue license, and of this number only 231 pay anything to the state and county. The license due the latter amounts to over \$200,000 annually, and of this amount only \$70,000 is collected. The officers are small grocery keepers who have been late because of the "pull" they have in politics.

Typhoid Raging in Wheeling.

WHEELING, Sept. 5.—An epidemic of typhoid fever is raging in the 6th and 8th wards of this city. More than 100 deaths have occurred, and there are now nearly 250 cases being treated. One physician in the 8th ward has thirty cases. In several instances whole families are prostrated. The epidemic is attributed to the use of the impure water from the wells.

THE COTTON CROP.

Secretary of the New Orleans Cotton Exchange in His Annual Report.

NEW ORLEANS, Sept. 4.—Secretary, Hester, of the New Orleans cotton exchange, has completed the final details of the cotton crop movement, the principal figures of which were issued on Sept. 1. His introductory remarks state that the cotton crop of the United States for the year ending at the close of August, 1891, is 3,652,379 bales, the largest crop ever grown by 1,841,275 bales.

In reference to the receipts at American ports, Mr. Hester says that with the enormous crop the movement in every direction has been correspondingly heavy. New Orleans has handled more cotton than in any year, but one, of her history, her net receipts exceeding 2,000,000 bales for the first time since the war, and reaching within 80,000 of those in 1863, the largest autumn year. Galveston has passed the million mark for the first time, and Savannah has handled considerable more than a million bales, exceeding all previous records.

The gross overland movement for the year, after deducting interchanges between the different points of crossing and reshipping into the cotton belt, has reached 1,588,260 bales, exceeding last year by 181,580, and the year before by 181,680.

The heaviest gains in the overland have been at St. Louis and points above, on the Mississippi river, which show an excess of 287,000. Railroads out of Louisville are 95,000 bales ahead of last year; while Cairo, exclusive of through cotton for St. Louis, is short nearly 42,000 bales. Cincinnati and Virginia points also show a falling off of 113,000.

The statement makes foreign exports for the year: To Great Britain, 3,229,432; to France, 559,099; to the continent and channel ports, 1,890,291; a total, exclusive of Canada, of 5,778,822. The excess in foreign ports over last year is 878,382, of which Great Britain has taken 479,330; France, 86,262; the continent, 312,690. The report mentions shipments of American cotton from New York to Japan of 4,484 bales. Total takings for American consumption during the year were 2,622,923 bales, against 2,746,152. These embrace 2,027,392 by northern spinners, against 1,799,515 last year, an gain of 227,877; and 604,661 by southern spinners, against 546,884 last year, a gain of 57,765.

Secretary Hester has made a complete census of the southern mills. These show that South Carolina has become the largest consumer of cotton among the states of the south, Georgia, which ranked last year coming next. The consumption by states for this and last year is given as follows:

SIX PROMINENT MEN

Are Sent Into Exile by the President of Nicaragua.

NEW YORK, Sept. 3.—A dispatch received here from Corinto, Nicaragua, dated Aug. 23, says that among the passengers here today on the steamer Colima were six of the most prominent men in the republic of Nicaragua, who were sent to Costa Rica as exiles, by order of President Sacasa. The party included three members of the Nicaraguan senate—General Favalá, who was formerly president of the republic; J. D. Rodriguez, and Schamorro. The others were A. H. Rivas, E. Gazman and Pedro Ortiz. There has been much opposition to President Sacasa's administration, particularly among the upper classes, and, if current reports are correct, the president has frequently been obliged to keep in retirement, threats against his life having been made openly.

The exiles sent away today have been most pronounced in their opposition to the president, and he has finally determined to send them out of the country. His action led to an open revolt in Granada city, where the parties all live, which resulted in bloodshed. The prisoners were placed in a wagon today and sent by special train to Corinto. The wagon, guarded by troops, was passing through the streets when it was surrounded by a mob shouting for the prisoners' release. The soldiers were ordered to fire but no one was injured. The mob replied with a volley and killed seven men, including the governor of the district, the lieutenant commanding the troops, three soldiers and two bystanders.

The troops were brought to the scene and the mob soon dispersed without further loss of life. The prisoners were taken to Corinto and placed aboard a steamer which took them to Punta Arenas. Both Nicaragua and Honduras have troops stationed on the frontier, and open hostilities between the two countries are expected. The question of the Central American federation has led to jealousy and ill feeling among the different republics. Troops of Salvador and Guatemala are now stationed each other on the frontiers. The election in Guatemala for a successor to President Barillas will, it is believed, be the signal for the opening of a conflict in Central America.

THE RAIN WIZARD.

His Remarkable Success in Wyoming. He Is Asked to Hold Up.

CHEYENNE, Sept. 3.—Frank Melbourne, the rain wizard, had just returned to make more rain here when a committee called upon him and begged him to desist doing so.

There is a division shooting tournament of the Rocky Mountain Sportsman's association going on here, and the County Teachers' institute, the Mine convention and the State Fair race meeting, all public gatherings to follow, occupying the time till Sept. 12, would be greatly impaired by Melbourne's showery.

The wizard has agreed to comply with the wishes of the people, but says that nevertheless he will furnish half an inch of rain here on next Sunday. Those here who were skeptical are now convinced that there is something in Melbourne's system. The committee having the matter in charge took every precaution to obtain a satisfactory test of Melbourne's rain-making power, and the Oberவர் Ravenscroft rendered important assistance. The committee says that Melbourne has done what he agreed to. DISPATCH FROM MINISTER EGAN.

The Department of State Receives a Cablegram from Santiago.

WASHINGTON, Sept. 3.—At last the department of state has heard from Minister Egan. The news came in the shape of the following cablegram:

SANTIAGO, Sept. 1.—Bisnie Washington: Desires battle Valparaiso Aug. 28. Resolution entirely successful. President Balboa resigned the 29th. Revolutions fully installed. Everything tranquil. Egan's delay in receiving this report has been solved by the department. Acting Secretary Wharton has received information that telegraphic connection between Santiago and Valparaiso, the western cities, has been restored. The line eastward from Santiago to Buenos Ayres has been interrupted by heavy snow in the Andes mountains. A SEASON OF PROSPERITY.

The Manufacturers' Record Predicts Good Times for Fall and Winter.

BALTIMORE, Sept. 4.—The Manufacturers' Record of this morning publishes six pages of special letters from leading bankers in all parts of the south as to the financial condition and prospects of general business and farming interests. These reports uniformly show that immediately after the Baring failure southern merchants and bankers pursued a very conservative policy and in some cases commenced to curtail all their operations and to make preparations for a long period of monetary stringency, if should come. The effect of this, which lessening the volume of trade, has been a reduction of indebtedness and the placing of all business on a solid basis. It also resulted in the borrowing of less advance money by cotton planters than for many years, and hence the present crop has less indebtedness against it than crops of former years. In all parts of the south farmers are reported as less in debt than for years, many reports saying that their indebtedness is smaller than at any time since the war, due in part to reformed economy on account of the monetary stringency since last fall and in part to the large crops of the last few years. The low price of cotton in the spring caused planters to pay more attention to raising their own food supplies, and the south will probably be less dependent upon other sections for corn and wheat than ever before.

It is estimated that the grain crops of the south this year will aggregate nearly one hundred million bushels more than in 1890, and this, added to the large yield of fruits and vegetables, will keep at home at least seventy-five million dollars that last year went north and west for food stuffs. This will fully offset the low price of cotton, and if planters should advance, would be a clear gain to the southern farming interests. The yield of wheat, rice and tobacco promise to exceed the crops of 1890, and to add largely to the prosperity of the south. Bankers in all sections of the south report that, with business on a solid basis, with less indebtedness on the part of farmers and merchants than for many years, and with good crops assured, the prospects for fall and winter are never been more favorable. A period of great activity in solid substantial development is universally predicted.

FROM CAMP ARCADIA.

CAMP ARCADIA, Sept. 8th 1891.
DEAR REPUBLICAN:—I am again back on the mountain in this delightful camp with Mr. Goodlett, none the worse for my trip to Piedmont, though my stay in the valley of three days served to bring on a slight attack of hay fever. One day here cured it, however. It cannot live at this altitude, above the dew line.

Apropos of that trip to Piedmont, I have received, since my return to the mountain, a letter from Heflin, informing me that Mr. Longshore, in his speech there after the speaking at Piedmont, made the declaration that he had repeatedly challenged me to a refutation of the sub-treasury scheme and that I had failed or refused to do so. I have never received a challenge to debate with the gentlemen, save the one letter he wrote me prior to the Piedmont speaking. That simply informed me that the committee desired a joint debate at Piedmont and had requested him to notify me. Although I was here on the mountain sick, I responded both out of consideration for the good people of that region who had invited me and to preclude Mr. Longshore from saying that no one would meet him. As has been published, I took square ground against the sub-treasury bill and refuted his position as to its benefits, apparently to the satisfaction of a majority of the farmers present. At least that was the impression of disinterested gentlemen present at the speaking.

It is needless to say that I should not have alluded to Mr. Longshore in this letter but for the information contained in the letter from Heflin. But he nor others ought not to be permitted to put out the impression that Democratic speakers are afraid to meet the advocates of the sub-treasury bill, (which is to be made the basis of the third party movement) on the stump. The only reason Democratic speakers have not met these sub-treasury advocates has been because they have not been invited to do so. They have had too much politeness to obtrude themselves on Alliance meetings to which they have not been asked to come. But the argument will be heard from a Democratic standpoint. "The people are going to hear both sides of the question and then make up their judgment, each man for himself, and I have no doubt but that they will act patriotically and right. The men who are now going about preaching the new doctrine to the people act upon the presumption that they can be bought by the prospect of a flood of greenbacks, without regard to after consequences; but they will be tremendously mistaken. The spirit of 1861 is still alive in the people of the South. The men who offered their lives and their fortunes for their country then are still here in person or through their sons. Forty acres and a mule might prove a temptation to the emancipated slaves, but nothing can buy the principles of free white men. It is the crowning glory of our race that we had rather die for our country than to profit by its misfortunes. Our people will continue true to Democratic principles until they have wrought their perfect work in the utter destruction of the Republican party and secured to the people just laws and fair administration of the government. This is all the people of the South ask or want. Give us this, and with our genial climate and generous soil and other natural advantages we will soon be the richest people of the Union; and we can enjoy it too, for we will have the satisfaction of knowing it has been honestly earned by individual exertion and not taken forcibly from any other part of the people through discriminating legislation.

Mr. Goodlett and I are left alone in the camp now, others who have been with us having descended to the low grounds of sorrow. We shall have to stay here until frost or suffer the penalty of living in the valley. We shall not be as lonesome though, as we expected. We have some new neighbors in Engineers Montgomery and Dilly. They have bought out the improvements of Mr. Benedict, who had entered 160 acres in the mountains, and yesterday evening they moved up. They are about one mile from us, almost within sight and hearing. They are situated in a beautiful cove formed upon almost the very crest of this lofty mountain range, and henceforth will keep batchelor's ranch in fine style. They have a very comfortable frame house built by Mr. Benedict. They will at once furnish it well and will live as comfortably as at the Tredgar Inn, and this is saying a great deal, for friend Gasser knows how to make his guests comfortable as no other hotel man in all this country.

I learned something of cooking in the war, though we did not there have a very wide range of dishes to experiment on. This morning I tried my hand to see if I had forgotten this cunning in this regard. We had bought seventeen "frying size" chickens from Mr. Benedict when he left. This morning I got up before the sun, without interrupting Mr. Goodlett from his morning nap, proceeded to slay and "smother" two chickens, make coffee and prepare the baker's bread for breakfast. I am entirely too modest to reproducing here Mr. Goodlett's eloquent words of praise. However, among other gratifying things, he said that he had eaten at the crack restaurant of

the world from New Orleans to Mexico but that never in his life had he eaten so toothsome a chicken or drank a better cup of coffee. I was vain enough to be pleased with his commendation, as pleased as a young maiden when she receives her first declaration of love. I was once "strapped" in Texas, but I was not at all alarmed. I knew how to set type and was sure of my ability to work my way home. Now since I have discovered this latter gift or accomplishment I may laugh at any adverse fortune. A man who knows how to cook need never be afraid of starving. Good cooks are always in demand.

The farmers of Nancy's Creek valley and those of Rabbit Town valley are our next nearest neighbors after Messrs. Montgomery and Dilly. They are a thrifty, independent, self-sustaining, debt paying, law-abiding and moral set of people. No more quiet or better communities exist than in these two beautiful little valleys. We draw on them for eggs, butter and melons, as occasion demands, and they are most neighborly and hospitable. Some of them visit us in camp and kindly invite us to their homes. We shall go down the mountain on their side one of these days and break bread with them.

The order was published in his own paper, and in an interview with a reporter of his own town he justified it. The Herald also denies that George has beaten Barksdale in Mississippi, and that nearly all of the Alliance members of the Tennessee Legislature are against the sub-treasury bill. But these are facts nevertheless. The Herald ought to deal honestly with its subscribers and not try to suppress the truth.

Cotton is opening up at a much better price than farmers expected. Here in Calhoun, where the farmers do their own picking to a great extent, the good price for cotton will be a godsend; but in the "black belt" of the South, where farmers will have to pay double price for picking, no advance can help them much.

Fifteen dollars a bale for picking cotton will take all the profit out of it; but that is what the negro alliance men say they are going to have. Some of their Kansas sympathizers have no doubt put this into their heads.

Senator Morgan made great speeches at Selma and Birmingham this week. They are destined to have a profound effect upon the Democratic party of this State.

In the contest for the office of commissioner of agriculture, Judge Randolph, of Montgomery, has decided that the repeal of Sec. 139 of the code took away the Governor's right to appoint. The case will go to the Supreme Court.

COTTON PICKERS STRIKE.
Alliance men think it will work no harm in Georgia.

ATLANTA, GA., Sept. 7.—Col. Livingston, the president of the Alliance, when asked what he thought of the story about the strike in the Colored Alliance, says he does not think it at all probable that the farmers of Georgia will strike. The only effect in the State, in his opinion, may be to advance the price of cotton. Leading members of the Senate and House agree practically in that view. They all say there is no cause for alarm in Georgia.

But, unfortunately, the cost of production of cotton does not have anything to do with its price on the market. The price is fixed in Liverpool, regardless of what it costs to make it. If the farmers of Georgia have to pay seven dollars and a half more for picking a bale of cotton than heretofore, they will lose just that much. The loss to Georgia farmers, if the negro Alliance pickers win the fight, will be between seven and ten million dollars. So it will be in Alabama. Brother Livingston is just whistling to keep his courage up.

AGAINST THE SUB-TREASURY.

In yesterday's issue we gave the standing of the Tennessee Senate on the sub-treasury scheme, as ascertained by the Nashville Herald. The result was surprising in that not a single Senator expressed himself as adhering to the heresy, though eleven of the number were members of the Alliance.

The American of Friday gave the standing of the entire general assembly on this important question. It said:

There are 104 Democrats in this General Assembly. Of this 104, eighty-eight are opposed to the political views which the Alliance leaders claim to have the power to foist upon the Democratic party.

There are fifty Democratic Alliance members in this General Assembly of this fifty, thirty-six are uncompromisingly opposed to the policy which McDowell proposes to cram down the throats of the Tennessee Democracy. The other fourteen are non-committal. Not one Democrat in this Legislature is outspoken for the Ocala policy.

This is remarkable indeed and furnishes proof that the sub-treasury fallacy has not so large a following among Alliance men as is commonly supposed. The average Southern farmer is an old-time Jeffersonian Democrat and not disposed to take up readily with new doctrines.—Age Herald.

AGAINST THE SUB-TREASURY.

There are some very interesting and instructive figures to be found in another column, showing how the democratic members of the present general assembly stand on the sub-treasury question. Of the 104 democratic members of the two houses, the views of eighty-nine are given, the other fifteen not having been seen, and their views being unknown. Of this eighty-nine, seventy-nine are unequivocally opposed to the whole scheme and the other ten doubtful or non-committal. Not a single one interviewed committed himself unreservedly to the support of the favorite hobby of the Farmers' alliance organization. What makes it the more significant is that of the forty-three alliance men seen thirty-four are opposed to it and nine doubtful. Every democrat in the senate is opposed to the scheme, and fifty-four of the sixty-four whose views are known in the house.—Nashville Herald.

WE'LL STILL TRUST THEM.

Tuskegee News, which has been a warm friend of the Alliance, has this to say of the latest phase of affairs, in which it has become apparent that the third party element in the order are not only bent on the destruction of all the trusted leaders of the South, but also upon the complete obliteration of the glorious records made by Southern soldiery during the struggle for Southern independence.

All this ground was fully covered at the time contributions were solicited for the building of the Home, and it was fully demonstrated, that while Georgia could build and maintain a home for her old veterans, she could not appropriate a sufficient amount for pensions to do the old soldiers much good. We very much fear, that a way down at the bottom of this matter will be found the teaching of the third partyites who have recently invaded Georgia from Kansas, "Old war issues must be relegated to the rear," is the cardinal doctrine of these new found friends of the oppressed South. What do they mean? No people under the sun ever more completely acquiesced in issues settled by the arbitrament of the sword than have the people. At no time since the war have the people of the South ever attempted to revive any question settled by the war. What then do they mean? They mean that old war veterans must be relegated to the rear, that the South must cease to honor, or care for her heroic dead, and must throw overboard her living heroes who have fought her battles during the war, and since the war. If we will do this, then we can affiliate with the Northwestern Republicans in the organization of a new third party with negro equality for its chief corner stone. Mr. Simpson, one of the chief apostles of the third party, has declared that this movement will settle effectually and forever the race issue in the South. A warehouse where a farmer pawns his cotton.
How much does a farmer get on his cotton pawned at a warehouse?
The farmer gets \$1 out of every \$5.
Who gets the other \$4, the farmer or the government?
The government holds it to pay for interest, insurance, loss of weight, decline in price of cotton, etc.
Who devised the sub-treasury system?
It was either a syndicate of politicians or a syndicate of speculators.
Can a speculator deposit cotton in the sub-treasury?
A speculator can deposit cotton in the sub-treasury.
How many bales can he deposit in the sub-treasury?
If he has \$60,000,000 he can deposit the entire crop, valued at \$70,000,000. How can speculators do this?
Say every fourth or tenth county had a warehouse. Speculators with \$100,000 buy cotton, send it to the warehouse, draw \$50,000; buy again and send it to the warehouse and draw \$50,000; buy again, send that to the warehouse and draw \$10,000; buy again, deposit and draw money, and so on until \$100,000 would corner \$500,000 worth of cotton. Margins would not bother him, and he could hold so long as he paid interest, insurance and warehouse dues. In this way speculators could corner and control \$300,000,000 worth of cotton with one-fifth that amount of money. Would the speculator get half the crop raised by farmers on shares?

Every true man ought to seek the truth and be willing to hear all sides of questions which to affect their interests for weal or woe. A cause that shuns free discussion and works in the dark may well be distrusted by the people. "Error cannot live while reason is free to combat it." Truth is not afraid of the light. By the way, what sort of Democracy is that which seeks to keep the people from hearing Democratic speaking?

Replying to the resolutions of the Woodside Alliance, the Alliance Herald quotes one of the resolutions as below and then coolly admits, as will be seen, that every member of the Alliance should have known what was coming when he joined the order. It makes no denial of the charge that the intention is to take them outside the Democratic party, but tells them in effect, "you ought to have known where it would lead you." How were they to know, when they were assured solemnly that joining the order would not conflict with their politics and that it was non-partisan or non-political. Every man who has joined the Masonic fraternity was assured before he took the oath that it would not interfere with his politics or religion. What a cry of "shame" would go up, if the attempt should be made to break this solemn pledge and lead the order into politics. Here is what the Herald says:

"Attempting to force the people to a blind and unthinking endorsement of wild and reckless schemes of finance and revolution, to form a third party for the disruption of the unity of the south." Every member of the Alliance should have comprehended and understood its purposes before he offered for membership. When he ascertained that it was for the uplifting and upbuilding of the farmer, he should have comprehended that all that might be necessary to accomplish this end was included.

In replying to the Woodside Alliance resolutions the Alliance Herald trots out the old statistics about the farm values decreasing from 80 to 22 per cent. &c. At the first settlement of this country before any towns, cities, manufacturing industries &c., were erected the farm values comprised probably 100 per cent. The figures used by the Herald do not prove that the farm values have decreased from 80 to 22 per cent. Farm values are greater to-day than ever before; but in the meantime great manufacturing interests, great cities, great railroad lines and other enterprises representing wealth have grown up and the estimate as to farm values have become relative. It does not mean that the values of farm property has decreased but that other forms of wealth have increased. In view of the enormous growth of manufacturing interests, the vast sums that have been put in the building of railroads, steamship lines and great cities, it is creditable to the farming industry that it has held its place so well as a representative of the wealth of the country and it is yet the leading wealth producing industry of the land. Farm values have steadily increased and have not decreased. Other interest representing part of the wealth of the country have grown up. That is all. It may be illustrated this way: John Jones is worth \$20,000 and is the richest man in the neighborhood. Ten years hence he may be worth \$30,000; but in the same neighborhood and become worth \$50,000 to \$60,000. Because another man has got more, it does not argue that Jones, who has increased his wealth \$10,000 has done badly in business. It is within the memory of many men in this country, when land was to be had at 12 1/2 cents an acre. Now almost any kind of land is worth from \$5.00 an acre and upwards. Land in Illinois, worth only a few cents an acre a few years ago, is now worth \$100 an acre. No the farm wealth of the country has constantly increased. But the men who have set out to deceive the farmers do not scruple to mislead them by such show of comparative figures as are calculated to deceive the unthinking.

CHOCOLOCO.

Speaking, Dinner, Racing &c.

The good people of Chocococo valley had a public day at Chocococo town Thursday the 19th inst. Trotting matches, baseball, foot racing, a capital dinner and public speaking occupied the day.

The lovely ladies of that fine valley graced the occasion with their presence and added much to the pleasures of the day.

The speakers arrived on an early train and spent the interval between arrival and the hour for speaking in pleasant converse with the good people of the place and the farmers as they came in from the adjacent plantations. By the hour for speaking two hundred farmers were on the ground, and when the school house bell tapped for assembling the house was filled to its utmost capacity with ladies and gentlemen and many stood at the doors and windows. Considering the busy season of the year and the fair day for out-door work the attendance was flattering to the speakers. Col. Lock, the rock-ribbed Democrat, was master of ceremonies and introduced the speakers. Dr. Overton, of Anniston, opened the ball. Mr. Grant followed. Then came dinner and in the evening Gen. Forney spoke. About three hours were occupied in speaking and during the whole time the most earnest and respectful attention was given by the audience, indicating the profound interest the people are taking in the questions of the day. TALLADEGA, Sept. 19.—Dr. B. W. Groce addressed an audience here today. Several citizens of the city were in attendance and about 150 members of the alliance were also present.

Dr. B. W. Groce, formerly state lecturer for the alliance spoke for two hours; among his utterances I quote the following: "We want relief, we are going to have it, no matter from what source it comes." In speaking of the relief he said: "We cannot get relief from the democratic party."

In speaking of the money question he said: "Sole-leather with the stamp of the government on it is as good as gold."

Prayed for Warm Weather.

MONMOUTH, ILL., Sept. 23.—Two weeks ago the farmers of Warren county were praying for warm and dry weather to save their corn crop. Their petitions were more than granted. A big crop of corn was assured, but the situation is alarming. The oldest residents never experienced hotter weather in September. Vegetation is literally burned up. The farmers are compelled to feed their stock as in winter, and many are hauling water, as wells and streams are dry.

Yesterday and Monday the mercury registered 100 in the shade.

Here is a sample what is oppressing the farmers. It is a Republican measure, and shows what that party is willing to fasten on the people: "A Chicago firm last week imported from Austria 1,400 worth of pearl buttons, and paid \$5,000 duty thereon. This is said to be the first large importation since the McKinley bill went into effect. The good housewives, influence is said to have effected the revolution in the West last year, should reflect on this. When they buy imported pearl buttons they pay 14 cents for the buttons and 30 cents tax. If they buy American made buttons, they pay 14 cents for the buttons and 30 cents premium to the manufacturer."—Talladega Mountain Home.

Philadelphia Record: A friend in Cuba has made Charles Delmonico, of New York, a gift of twenty-five cigars, a part of 1,000 made to order for the Prince of Wales, who will pay at the rate of \$1,800 per thousand for them; so that their retail price, if they could be obtained at all, would be 1.50 apiece at the factory. But, of course, there is at present no market for such costly smokes in this country. Only the heirs apparent and the Delmonicos of earth can afford to puff them. Other smokers of less pretense will have to wait till McKinley's reciprocity shall have precipitated the promised area of prosperity, if they crave the taste of such princely weeds.

It is now claimed that there is a deficit in the world's supply of wheat and rye of 200,000,000 bushels. If that be so wheat will go to 32 per bushel and the Western farmer will become rich. But then, that won't do the Southern cotton raiser much good. He will get less for his cotton and pay more for his bread. When will this state of things cease. Before the war Calhoun county produced good wheat. Why can't it be grown here again? One acre in wheat will put in would make enough flour to feed an average family, and we understand there are several good flouring mills in the county.—Hot Blast.

TOO MUCH POLITICS GET A PREACHER IN TROUBLE.

WICHITA, KAN., Sept. 20.—There is trouble in the Methodist Church here, and the Rev. J. D. Botkin, presiding elder of the South-west Conference, finds himself called upon to answer both in the church and in court to charges of malicious libeling Police Commissioner C. E. Jones, a brother elder. During a speech at a prohibition meeting Rev. Mr. Botkin, in talking of the Board of Police Commissioners, said one member was a perjurer and a scoundrel. Jones asked Botkin if he was the Commissioner meant, and was answered in the affirmative. It is supposed Botkin, who is quite a politician, is now trying to play even with Jones, who vigorously opposed the preacher when he was running for the Governorship on the Third party ticket.

I see that Mr. R. M. Humphrey, of Texas, the self constituted Alliance leader, has placed the colored Alliance in a very false position before the public. His infamous circular proclaiming a cotton pickers' strike is one of many similar attempts which he has made to deceive and mislead the colored people. When the public shall know Mr. Humphrey, and how he came to the position that he now occupies in the Alliance the fallacy of the cotton pickers' movement will be clearly seen. While we are willing to agree upon any just liberal and open plans to better our condition as laborers and farmers, we object to all unreasonable measures as proposed by Mr. Humphrey.

The press has made a mistake in publishing Mr. Humphrey as the leader of the colored Alliance. No body of colored Alliancemen have ever met in convention or any other capacity and appointed Mr. Humphrey the leader of the Alliance organizations. He is the wrong man, a white man, who without invitation, forced himself into the negro ranks, knowing these facts I safely say that the farmers need not give themselves any uneasiness as the effect of his proclamation. The strikers will not number 200. Seven-tenths of the members of the Alliance are direct farmers. At Mr. Humphrey's figures the picking of one bale of cotton would cost them at least \$20, making the whole cost of one bale not less than \$38. Therefore, as president of the National Consolidated Alliance which constitutes the real and true Colored Alliance organization in the United States, and which represents more than 1,000,000 Alliancemen. I condemn the movements as being unreasonable, and illegal, a fraud upon the Colored Negro, an imposition upon the Negro, and an outrage upon the Alliance cause.

KANSAS MORTGAGES.

The Greatest Debt in the Most Prosperous Sections.

WASHINGTON, Sept. 11.—The census office has issued a bulletin which gives the mortgage indebtedness of the State of Kansas by counties. Total assessed valuation of real and personal property in 1890 not including value of railroad property which is placed at \$75,568,233, was \$290,593,711. Estimated true value is between eight and nine hundred million. It is found that Kansas has a mortgaged debt of \$275,485,408, which not include the State and railroad land contract debt of \$7,601,718. This debt is 27 per cent of the estimated true value of all taxed real estates. The average amount of debt per mortgaged acre is placed at \$6.67. Of total mortgage debt \$167,145,039 is on acres, and \$68,340,069 upon lots. Thirty-four per cent of the total debt in force against acres is on real estate in Western half of the State where, it is said, values are low and where settlement was made but a few years ago. Supt. Porter says that the largest debt exists in sections where there is the greatest prosperity and where there has been an advance in improvements.

What it may Lead To.

The cotton-picking strike has created considerable comment all over the cotton region, and while there has been as yet no evidence of anything of the kind as likely to take place in this section, it goes to show to what extent the colored Alliancemen go, and a feeling of unrest and anxiety is aroused. It would be a serious thing for the gathering of the cotton crop to be interrupted, because there are very few farmers in a condition to stand a loss which the delay would be sure to bring. Speaking of the circular issued and circulated in Mississippi, calling on the colored laborers to insist on their demand for higher pay for cotton-picking, Congressman Catchings says: "It is the work of a mischief-maker. The hope, of course, is to embroil the laborers with the planters and make trouble. The amount of wages proposed for picking the crop is excessive and unreasonable. It is equal almost to one-sixth of the value of the cotton. The planters cannot afford to pay any such wages to laborers and will not do it. The threat of a strike among farm hands is not lightly to be considered. Cotton is a perishable crop. When it is ripe for picking, the picking must be done promptly, or else there is a heavy loss. I feel, however, that the planters will be equal to the emergency."

THE THIRD PARTY.

A Call Issued by the Various Factions in Michigan.

LANSING, Mich., Sept. 11.—Last May at a conference between representatives of the Farmers' Alliance of Michigan, Knights of Labor, Patrons of Industry and Citizens' Alliance and Industrial Brotherhood an address was issued to the members of the subordinate lodges of the orders represented requesting them to vote on a proposition looking to independent political action, as the returns showed ninety per cent of members were in favor of such action, their representatives met here yesterday and issued a call inviting all industrial and reform organizations to send delegations to a convention to be held in this city the last week in December for the purpose of confederating those organizations for independent political action and to elect delegates to a national convention to be held at Washington, February 22nd 1892.

Violation of the Cigarette Law.

Some months ago the State of Alabama passed a law prohibiting the sale of the deadly cigarette to persons under eighteen years of age. The cigarette is, without doubt, preparing for the grave more young men and boys today than anything else, leaving out the liquor habit. When the law was passed prohibiting the sale of them I was in hopes that it would, in a great measure, stop the smoking of them. But the sale of them goes on in defiance of the law. You may at any time see boys hardly large enough to be without a nurse puffing away at them. And they are bought right here under policemen's noses, and I don't think there has been a single arrest made.

I think, for one, that it would be well for the police to see that our merchants stop the practice of letting these little toddlers, boot-blacks and go as we please boys have the poison.—J. R. L. in Anniston Hot Blast.
